

## **Current tasks of Rosatom State Corporation in the field of ensuring environmental safety**



- 1. Update of the Environmental policy of Rosatom State Corporation and Integrated Plan for its implementation in accordance with the strategic documents of the Russian Federation and changes in environmental legislation.
- 2. Development of a Methodology for the application of environmental effectiveness indicators for nuclear industry facilities in accordance with the course on the use of the system of sustainable development indicators determined at a meeting of the State Council of the Russian Federation on the issue "The Environmental development of the Russian Federation for the benefit of future generations" (December 27, 2016).
- 3. Development of the Methodology for introducing a new system of rationing in the field of environmental protection and its impact on the nuclear facilities activities.
